<ul> <li>SHARE</li> <li>Gifts are split between the District Designated Fund (DDF) and the World Fund</li> <li>Gifts are invested for three years</li> <li>After that, a district can spend its DDF on: <ul> <li>Global grants</li> <li>District grants (up to 50% of the DDF)</li> </ul> </li> </ul>
<ul> <li>Donations to the PolioPlus Fund, Disaster Response Fund, Rotary Peace Centers, or other districts</li> </ul>
<ul> <li>World Fund</li> <li>Trustees use to provide match for global grants, programs, or urgent needs</li> <li>Rotary districts may apply for funds through global grants</li> </ul>
Areas of focus Contributions support projects in: • Peacebuilding and conflict prevention • Disease prevention and treatment • Water, sanitation, and hygiene • Maternal and child health • Basic education and literacy • Community economic development • Environment
<ul> <li>Gifts are matched 2-to-1 by the Bill &amp; Melinda Gates Foundation</li> <li>Funds grants to two of Rotary's Global Polio Eradication Initiative partners: UNICEF and the World Health Organization</li> <li>Supports polio immunizations, environmental surveillance, transport of vaccines and volunteers, and research</li> </ul>
<ul> <li>Contributions fund disaster response grants</li> <li>Donations cannot be directed to a specific disaster</li> </ul>
<b>SHARE</b> Annual earnings from these gifts flow through SHARE to generate DDF and World Fund money, but are not included the current three-year investment cycle
World Fund Annual earnings are used for global grants, programs, and urgent needs
<b>Areas of focus</b> Annual spendable earnings support projects in the area of focus the donors choose when they give
<b>Rotary Peace Centers</b> Annual earnings are used to support the Rotary Peace Centers
HOW THEY WORK
<ul> <li>A donor who makes a one-time gift of \$15,000 or more may choose to fund a grant in an area of focus</li> <li>Rotary staff members consult with donors to ensure that their philanthropic goals are compatible with Rotary's guidelines</li> </ul>
<ul> <li>Donors who give \$10,000 or more may establish an account within Rotary's donor advised fund and will receive a charitable receipt suitable for U.S. tax purposes</li> <li>Account advisors can recommend grants to any U.S. public charity or other entity that's approved by the IRS, which will support Rotary's work through a yearly transfer to the Annual Fund</li> </ul>
