<p>Annual Fund The main source of funding for grants</p> <p>Donors can direct Annual Fund gifts to:</p> <ul style="list-style-type: none"> • SHARE • World Fund • An area of focus 	<p>SHARE</p> <ul style="list-style-type: none"> • Gifts are split between the District Designated Fund (DDF) and the World Fund * • Gifts are invested for three years • After that, a district can spend its DDF on: <ul style="list-style-type: none"> ○ Global grants ○ District grants (up to 50% of the DDF) ○ Donations to the PolioPlus Fund, Disaster Response Fund, Rotary Peace Centers, or other districts <p>World Fund</p> <ul style="list-style-type: none"> • Trustees use to provide match for global grants, programs, or urgent needs • Rotary districts may apply for funds through global grants <p>Areas of focus Contributions support projects in:</p> <ul style="list-style-type: none"> • Peacebuilding and conflict prevention • Disease prevention and treatment • Water, sanitation, and hygiene • Maternal and child health • Basic education and literacy • Community economic development • Environment
<p>PolioPlus Fund Supports polio eradication</p>	<ul style="list-style-type: none"> • Gifts are matched 2-to-1 by the Bill & Melinda Gates Foundation • Funds grants to two of Rotary's Global Polio Eradication Initiative partners: UNICEF and the World Health Organization • Supports polio immunizations, environmental surveillance, transport of vaccines and volunteers, and research
<p>Disaster Response Fund Supports disaster relief and recovery efforts</p>	<ul style="list-style-type: none"> • Contributions fund disaster response grants • Donations cannot be directed to a specific disaster
<p>Endowment Fund Ensures the long-term viability of the Foundation's grants and programs; spendable earnings are directed to grants and initiatives annually</p>	<p>SHARE Annual earnings from these gifts flow through SHARE to generate DDF and World Fund money, but are not included the current three-year investment cycle</p> <p>World Fund Annual earnings are used for global grants, programs, and urgent needs</p> <p>Areas of focus Annual spendable earnings support projects in the area of focus the donors choose when they give</p> <p>Rotary Peace Centers Annual earnings are used to support the Rotary Peace Centers</p>
SPECIAL GIFT TYPES	HOW THEY WORK
<p>Directed Gifts</p>	<ul style="list-style-type: none"> • A donor who makes a one-time gift of \$15,000 or more may choose to fund a grant in an area of focus • Rotary staff members consult with donors to ensure that their philanthropic goals are compatible with Rotary's guidelines
<p>Donor Advised Funds (DAFs) Designed under U.S. tax law</p>	<ul style="list-style-type: none"> • Donors who give \$10,000 or more may establish an account within Rotary's donor advised fund and will receive a charitable receipt suitable for U.S. tax purposes • Account advisors can recommend grants to any U.S. public charity or other entity that's approved by the IRS, which will support Rotary's work through a yearly transfer to the Annual Fund
